### 1. Call the meeting to order.

A motion was made and seconded to call the meeting to order at 12:05 p.m.

# 3. Discussion:

Discussion of the Ambulance situation and money to be budgeted for the FY 2018-2019 year. With Derby Line out of the picture and never receiving anything from them for FY 2018-2019. Lyndon Rescue came to us with a \$15,500.00 raise for a total of \$21,500.00. The Board found this to be not negotiable and asked if Lyndon would accept a counter offer of \$25,000.00 to cover the whole town. Lyndon Rescue agreed upon the acceptance of 4 other Towns and if just one would drop out then this figure would go even higher. The Board then decided to check into Newport Ambulance and their offer was \$40,000.00 using the census of 2010 population of 749. The Board questioned the \$40,000.00 in comparison to Charleston with a 2010 census population of 1023 and was offered \$29,462.00. The Board did not agree with these figures in comparison of the census and will go back to Newport questioning the difference and how they came to these 2 different figures.

After a verbal telephone conversation with Jon Bouffard and a verbal from Jon agreeing that the Town of Morgan was still covered for ambulance service through June 30<sup>th</sup> 2018 from payment made in July to Lyndon Rescue in the amount of \$5,899.00 a decision was made.

#### 4. Decision:

A motion was made and seconded to approve an estimated \$30,000.00 for ambulance coverage pending future negotiations.

#### 5. Other Business:

a. A request from the Town Clerk & Treasurer for \$3,000.00 for the Town Clerk & Assistant to be paid for work needing to be done during vault renovation consisting of moving all records

in the vault and computer/equipment to the Town of Derby during renovation time and also an extra \$2000.00 to mileage for travel to and from Derby during the time of renovation.

A motion was made and seconded to approve to approve these changes from the last meeting of January  $24^{\text{th}}$  Special Select Board Budget meeting.

A motion was made and seconded to approve a budget of \$659,538.45 not including appropriations and Sheriff's Department that will be voted on at Town meeting.

b. Orders #17019 to review approve and sign for payment.

A motion was made and seconded to approve Orders#17019 in the amount of PR - \$4,891.75 and AP - \$2,581.02.
