1. Call the meeting to order.

2. Make any changes/additions to the agenda as needed.

A motion was made and seconded to add 6 things.

- A. Bruce Remick and speeding on 111. Bruce had come to the Board about a year ago with concerns of speeding on VT Route 111. Bruce, now a Board of Director member for the Seymour Lake Association, has been invited to the December 13th Select Board meeting for another discussion to represent both his and fellow SLA members VT 111 concerns and ideas for mitigation. The Board also asked Tammy to invite the Sheriff's Department as well.
- B. Brian Brock concerns of excessive turnouts on Sunset Drive on his father's land: Brian is concerned of the approximately 18 roadway turnouts on his Dads farm land and that they are causing problems with maintaining the fields. Eric Pope and Shawn Austin will meet with Brian and John Brock on October 26th 2021 to discuss this and to figure out a way to better mitigate roadway drainage issues.
- C. Radar Speed Signs quote from Marlin Controls Inc. in the amount of \$18,600.00 for 4 of them. The Select Board is looking to take action to mitigate speeding on VT 111.
 - A motion was made and seconded to put on the warning as an article for the Town's people to vote on at Town Meeting 2022.
- D. Down Signs on Sunset and Meade Hill Road. Eric will talk to Shawn Austin on October 26th 2021.
- E. Update on Northeast Kingdom Broadband from Larry Labor. Larry updated the Board on 2 meetings that he attended and said that Broadband is coming. There has been some changes from Optical line termination cabinets to possible point to point and wireless connection in place of poles when underserved sites are off grid or distance is not optimal.

F. The Beaver problem on Gore Road: Jerry Whitehill has raised concerns about Beaver activity at Mud Pond. Shawn Austin and Eric Pope will discuss mediation on October 26th 2021. Jerry Whitehill will be invited to the next meeting if he still has concerns.
