1. Call the meeting to order.

a. Speed count update: Eric spoke to Doug Morton from NVDA regarding the speed counts that have been conducted in town. Doug is in the process of compiling all of the final data, once completed, he will share the results with the Select board. A speed count is required prior to and as part of the process of installing radar speed feedback signs.
b. The town is seeking a Morgan resident to represent the town on the NEK Broadband Governing Board. Erick Pope is currently the Primary member for the town but is hoping to pass along the responsibility. The commitment consists of Monthly meetings (via zoom currently) and periodic review of emailed materials; any prospective member would occasionally be requested to provide updates to the Select board. d. FYI-Sunset Drive has had some work done to the road and ditching. The board is looking into a long term rather than a repetitive fix. The board will seek funding for this and will try to be able to get something done starting in the 2023 year.
